At 7:00 p.m., Chairman George Schuitema called the meeting to order.

All present joined in the pledge to the flag.

Recently appointed Commissioner Edwin Prom was introduced.

ROLL CALL. Members present: Commissioners Eich, Gardner, Hearn, Prom, Schuitema and Serviss. Members absent: Commissioner Heim.

Staff present: Secretary Patty Meyer and Administrator Charity Mitchell.

Guests: Trustee Erik Gardner and Village President Marcy Meyer (arrived at 7:10 p.m.).

CONSIDER APPROVAL OF THE MINUTES OF THE MARCH 28, 2024 MEETING. Commissioner Serviss made a motion to approve the minutes of the March 28, 2024 PZC meeting as written. WORKSHOP: CONSIDER HOLDING A PUBLIC HEARING ON THURSDAY, JUNE 27, 2024 AT 7:00 P.M. TO CONSIDER A REQUEST FOR A VARIANCE FOR AN 8' PRIVACY FENCE IN THE FRONT YARD SET BACK AT 536 MAXWELL STREET. Petitioner was not present. Administrator Mitchell answered questions from the Commission.

Commissioners had no problem with a privacy fence, but expressed concerns about the 8' height being excessive and that the fence would be too close to the sidewalk, affecting visibility of sidewalk and street for parking lot patrons.






